# Chapter 3

#### **CITY GOVERNMENT**

3.01		INCORPORATED CITY

The City of Blair is a duly incorporated city existing pursuant to its original charter and Chapter 62 of Wisconsin Statutes. Section 62.02 and 62.04 of the Wisconsin Statutes are hereby incorporated by reference. Further, the City is governed by this code, Chapter 62 through 66 of the Wisconsin Statutes, acts of the legislature and the Wisconsin constitution.

## 3.02 CITY BOUNDARIES

The boundaries of the City of Blair are set forth on the official City Map. The City Map, describing the corporate boundaries of the City is on file in the office of the City Clerk and is hereby incorporated by reference. A certified copy of the corporate boundaries of the City of Blair has been filed with the Secretary of State of the State of Wisconsin, pursuant to Section 62.02 of the Wisconsin Statutes.

#### 3.03 WARD BOUNDARIES

The City shall be divided into three wards as follows:

(1) <u>FIRST WARD</u>: The First Ward shall comprise all territory within the city limits of the City of Blair which lays East and South of a line described as follows:

Commencing at a point where South Tappen Coulee Road intersects the South Boundary of the city limits;

- a. thence North on South Tappen Coulee Road to East Olson Street
- b. thence West on East Olson Street to South Knutson Street;
- c. thence North on South Knutson Street to East Center Street;
- d. thence West on East Center Street to North Park Road:
- e. thence North on North Park Road to South side of railroad tracks to Western boundary of Elland Road;
- f. thence all of annexed land to the east of Elland Road that is South of the railroad tracks.

- (2) <u>SECOND WARD</u>: The Second Ward shall comprise all territory within the city limits of the City of Blair lying West of the First Ward and the Third Ward.
- (3) <u>THIRD WARD</u>: The Third Ward shall comprise all territory within the city limits of the City of Blair described as follows:

Commencing at a point where South Tappen Coulee Road intersects the South Boundary of the city limits;

- a. Thence North on South Tappen Coulee Road to East Olson Street;
- b. Thence West on East Olson Street to South Knutson Street;
- c. Thence North on South Knutson Street to East Center Street;
- d. Thence West on East Center Street to North Park Road;
- e. Thence North on North Park Road to Skumlien Road;
- f. Thence East on Skumlien Road to Eastern boundary of city limits;
- g. Thence North of East boundary until intersects North boundary of city limits.
- h. Thence West on North boundary to Granberg Hill Road;
- i. Thence South on Granberg Hill Road to Mill Road;
- i. Thence West on Mill Road to North Gilbert Street, extended;
- k. Thence South on North Gilbert Street to West Broadway Street;
- 1. Thence West on West Broadway Street to South Urberg Avenue;
- m. Thence South on South Urberg Avenue to 4<sup>th</sup> Street;
- n. Thence West on 4<sup>th</sup> Street to the boundary line of City of Blair and Town of Preston;
- o. Thence follow city southern boundary back to Tappen Road.
